The Executive Director would address conflicts of interest for employees.

Compensation for all other employees is determined by the Executive Director taking into consideration of cost of living and performance. Salaries are reviewed by the Treasurer and approved by the Board as part of the annual budgeting process. Support for key employee salary decisions is maintained in the employee file for a period of 7 years.
