THE MAJORITY OF THOSE VOLUNTEERS WERE PAIRED WITH A YOUTH OR A SIBLING GROUP WHO HAVE AN OPEN DEPENDENCY AND NEGLECT CASE IN DENVER JUVENILE COURT. IN ADDITION, 25 VOLUNTEERS WORKED WITH THE OLDER YOUTH PROGRAM MENTORING YOUNG ADULTS WHO ARE TRANSITIONING FROM FOSTER CARE TO INDEPENDENCE. IN TOTAL, 360 CHILDREN AND YOUTH WERE SERVED.
