OUR PROMISE

Today, children and youth who have experienced abuse or neglect are among the most vulnerable populations in America. Many who enter foster care have endured physical, psychological or emotional trauma and years of uncertainty – waiting for a permanent solution. These early experiences have lasting effects, increasing the risk of challenges such as homelessness, incarceration, and unemployment. They are also more vulnerable to exploitation and trafficking.

There is a simple and proven way to change that trajectory: **A CASA Volunteer.**

CASA – which stands for Court Appointed Special Advocate – a trained community member appointed by a judge, advocates as an agent of the court for a child's best interest. CASA volunteers work alongside caseworkers, attorneys, and families to ensure that every child's voice is heard, and their needs are prioritized.

When a young person has someone in their corner – someone who listens, speaks up, and shows up – their chances of success grow dramatically. They are more likely to thrive in school, find stability, and build a future full of possibilities.

Dear Friends and Supporters,

As we reflect on 2024, we are deeply proud of the thousands of hours devoted to serving more than 300 children and youth across Denver County. In a time when volunteerism is on the decline nationwide, 224 committed community members stepped up for our kids—and for that, we are immensely grateful.

Over the past few years, Denver CASA has made intentional strides to diversify our volunteer base so that every child can have an advocate who understands and reflects their unique background and experiences. This effort has paid off: we saw a 21% year-over-year increase in CASA Volunteers who are men, people of color, or members of the LGBTQIA+ communities. Many of our volunteers, board members, and staff also bring personal or professional experience with the child welfare system, including teachers, social workers, and attorneys. Their expertise has been especially valuable when assigning complex or high-needs cases.

While all CASA Volunteers work closely with professionals to ensure children are placed in safe, stable environments, they also play a critical role in securing additional services. Last year, 69% of volunteers advocated for mental and physical health services, and 75% helped secure educational evaluations and interventions. These efforts ensure that children and youth not only feel safe but also receive the support they need to heal and thrive.

However, the challenges our children face are growing. Many are experiencing heightened anxiety and stress—not only from instability at home but also from the broader uncertainty and division affecting communities across our state and nation. Children from immigrant families and LGBTQIA+ youth, in particular, are often navigating added layers of fear and discrimination. As a result, our CASA Volunteers need—and deserve—more training, resources, and support to serve these populations with empathy, knowledge, and care.

At Denver CASA, we remain steadfast in our mission: to provide every child with a dedicated advocate and the individualized support they deserve. With your continued partnership, we will keep showing up, speaking out, and standing strong—for every child, in every circumstance.


FINANCIALS

In 2024, 1,750 Denver children were referred to the Colorado Department of Human Services due to concerns of abuse or neglect. Nearly 900 entered foster care, which is a stark reminder of the challenges facing our community's most vulnerable.

But hope is never too far. In Denver's 2nd District, 213 CASA Volunteers stood by 307 children and youth, offering stability, advocacy, and encouragement. From strengthening family ties to mentoring older youth, our volunteers made a lasting impact when it mattered most.

The generosity of our donors and partners, in 2024, fueled essential services, innovative programs, and deeper community impact.

Because of you, lives are being transformed—one child at a time. We remained focused on delivering life-changing advocacy and support, with 73% of total expenses directly funding programmatic services.

ONE VOICE

Changes A Life

Sometimes, the universe brings the right people together at just the right time. That's exactly what happened with Nicole and Zhi*, whose paths crossed over a year ago—and neither of their lives have been the same since.

Zhi, who is deaf, came to the United States from China at the age of six. With no language skills and limited support, he faced immense challenges. Though he was adopted by a family with hearing impairments, the placement proved unstable. His teachers, recognizing his unmet needs, stepped in to provide basic necessities like food and properly fitting clothes, which they kept at school just for him.

At age 10, Zhi entered the child welfare system under a Dependency and Neglect (D&N) case. Now 17, he has spent much of his time with a consistent foster father, with whom he shares a positive relationship. But it was clear he needed more—someone to truly advocate for his unique needs.

That someone was Nicole.

Nicole, a CASA Volunteer, brought a rare combination of experience and empathy to Zhi's case. With a background in international adoption -specifically from China-and a degree in American Sign Language, she was uniquely


She worked tirelessly with his team to ensure he had the tools he needed to thrive: video relay services, a phone, and visual alarms including a bed shaker and strobe lights. For the first time, Zhi could wake up independently and arrive on time to school small victories that helped him stay on track with his education.

Nicole's advocacy didn't stop there. Knowing Zhi's love for soccer, she helped arrange for him to attend a Colorado Rapids game with a family considering adoption. It was a joyful experience. This summer, Zhi is attending a soccer camp, specifically one for deaf youth -another first, and another step toward a brighter future.

There are still challenges ahead, but Zhi is thriving. His confidence is growing, his world is expanding, and his future looks promising.

All because one advocate found her voice -and used it to change one life.

"It's been a pleasure getting to know Zhi. He's a great kid, and I truly enjoy our time together. I'm proud that my support has helped him prepare for adulthood, and I look forward to watching him grow and achieve his goals."

Everyone should have a Lesley

Since the launch of the Older Youth Program (OYP) in 2021, Lesley has been by Jenna's side—steadfast, supportive, and unwavering. Over the past four years, their relationship has grown into something truly transformative.

From the start, Lesley helped Jenna navigate the full spectrum of challenges that come with adolescence and early adulthood. Together, they tackled everything from high school academics and social dynamics to emotional regulation, family relationships, employment, and future planning. With Lesley's guidance, Jenna learned how to study effectively, write with confidence, and take pride in her work. Lesley didn't just help Jenna succeed in school—she helped her believe in herself.

That belief paid off. In May 2025, Jenna graduated from high school, earning special recognition from her JROTC program. It was a milestone that reflected not only her hard work, but also the consistent encouragement and accountability Lesley provided—checking in with teachers, helping Jenna advocate for herself, and showing up even when Jenna didn't feel like she could.

Their journey wasn't always easy. In quarterly meetings with the OYP Manager, Lesley and Jenna had honest, sometimes difficult conversations about trust, authenticity, and accountability. But those conversations became the foundation for a relationship built on mutual respect and growth.

Now, Jenna is stepping into a new chapter. Inspired by her experience in JROTC and the skills she's developed, she has chosen to enlist in the Navy. Lesley continues to be a trusted adult in her life—a permanent part of Jenna's support network.

At Jenna's recent OYP Exit Meeting, the room was filled with reflection and emotion. As she looked back on how far she's come, Jenna teared up and said something that captured the heart of their journey. "Everyone should have a Lesley."

Start Changing Lives Now

Cash Gifts

Gifts of cash to Denver CASA are eligible for the Colorado Child Care Tax Credit. Donors who make a qualifying contribution may claim a state income tax credit of 50% of the total qualifying gift.

Donor-Advised Funds (DAF)

Donor-advised funds allow you to make a charitable contribution, receive an immediate tax deduction, and recommend grants over time – so if you have a DAF, consider supporting Denver CASA with a grant recommendation today to reinvest in your community.

Appreciated Stock

Turn stock market gains into a gift to help children. If you make a donation of stock to Denver CASA, you will receive a tax deduction on the stock's full market value.

Qualified Charitable Deductions (IRA Charitable Rollovers)

If you are 70 $\frac{1}{2}$ or older, save on taxes by giving your QCD directly to Denver CASA.

Retirement Accounts

You can make legacy gifts by designating Denver CASA as a beneficiary.

Charitable trusts can be set up to generate a guaranteed life income for you as a donor while leaving a legacy to Denver CASA in the future.
